System requirements for BCBSLA

- **Grantee Portal:** A comprehensive portal for grantees to manage applications, reports, contracts, and more, with document sharing and electronic signature capabilities.
- **Multiple Applications:** Ability to create and manage various types of applications with different deadlines, cycles, matching funds, and customizable coding.
- Elimination of Paper-Based Processes: Transitioning from paper to digital processes for increased efficiency.
- **Grantee Reports/Benchmark Module:** A module for easy submission of reports and benchmarks, tracking outcomes and impact.
- **Reviewer Portal:** Intuitive portal for efficient scoring and evaluation of grant applications.
- Ad Hoc Reports and Dashboard: Generating customized reports and a customizable dashboard to track volunteer hours, donations, and pro bono work.

These must-have requirements were vital for BCBSLA to manage grants effectively, enhance data accessibility, and streamline their corporate social responsibility efforts. SmartSimple Cloud was chosen for its ability to meet these requirements and provide the necessary functionality and flexibility.
