The New York State Interest on Lawyer Account Fund ("IOLA") is a government agency with a mission to support qualified non-profit organizations providing civil legal representation to eligible clients and improving the administration of justice in New York State. Established in 1983, IOLA is governed by a fifteen-member Board of Trustees and operated by a staff of nine full-time employees in New York City.
